# Assess If Your Technology Solutions Are Siloed

From cameras to intercoms to access control, it's likely your campus has some (if not all) of these solutions in place. But having the right solutions and building the right system are two very different things. The 5 signs below help you assess the difference, and why it matters.



## **Cameras recorded the incident, but didn't help prevent it.**

Passive recording offers evidence after an incident, and lacks the analytics to put you in a proactive stance for future prevention.



## **Access controls are disconnected from visual proof.**

Without a camera tracking entry points, unauthorized visitors must be noticed by people—who are often stretched thin and can't track everything on their own.



## **Panic buttons are placed without traceability.**

If an alert is triggered and there's no location mapping linked to the button, response time suffers when your security staff can't see where they're needed.



## **Intercoms unlock doors without visitor screening.**

When cameras and intercoms aren't working together, controlled access is an illusion and becomes challenging to continuously implement and monitor.



## **Security systems live on different platforms and are managed independently.**

There's no single source of truth for incident response, recovery, or proactive planning.

**It's not about whether your campus has the technology—it's about whether that technology is working together to make a difference.**



# A Complete Picture for More Certainty

Security and safety technology that works together is a picture of certainty for everyone on campus. What does that look like? Explore the integrated campus below.

## Access Control

Know who entered, where they went, and when.

 **EXAMPLE**

Cameras, access control sensors, and network door stations work in tandem to monitor badge in, buzz in, and even doors that are propped open, alerting staff if operational standards aren't met.

## All Systems in a Single Dashboard

Staff members see the same scene from any device.

 **EXAMPLE**

Monitoring across three campuses is consolidated into a single view—one login provides oversight of camera feeds, access events, and active alerts. This also supports a single audit trail for incident documentation.

## Cameras and Analytics

Detect anomalies, flag weapons, alert staff.

 **EXAMPLE**

Beyond direct surveillance, vape and smoke detectors integrate with camera networks to offer real-time alerts that help you address persistent behavioral issues.

## Panic Alerts and Mass Notification

Trigger lockdowns, notify law enforcement, map incident locations.

 **EXAMPLE**

A panic alert system, network speakers, and mass notifications are all in sync to meet H.B. 84—three separate steps turned into a unified response sequence that removes human delay during potential emergencies.that are propped open, alerting staff if operational standards aren't met.
